




# WEST VIRGINIA CHILD ADVOCACY NETWORK

## WHO WE ARE

The WV Child Advocacy Network (WVCAN) is a network of 21 Child Advocacy Centers (CACs) across WV working together to support *hope, healing, and justice* for children affected by abuse.

Our official **service footprint covers 48 counties**, but our vision is for *every* child in WV affected by abuse to have access to a child advocacy center.



## THE WVCAN MISSION

We know that child survivors of abuse can *heal* from trauma with the right community response. This past year, **4,734** new children walked through the doors of a WV CAC.

- WV CACs conducted **4,603** forensic interviews last year in which **66%** of children disclosed abuse.
- **17%** of the children seen last year were there due to drug endangerment- four times *higher* than the national average.
- Criminal charges were filed in **833** cases WV CACs supported.



## CAC COMMUNITY IMPACT

**1 in every 10 kids will experience sexual abuse before they turn 18.** Without a CAC, child victims of abuse can be taken from agency to agency, enduring multiple interviews, and creating *additional* trauma.

A CAC is a **safe, child-friendly facility** where child protection, criminal justice, and treatment professionals work together to *investigate* abuse, hold offenders *accountable*, and help children *heal*.
